Notes to Applicants

- 1. Eligibility
 - a. Local students enrolled in a full-time locally-accredited undergraduate programme offered in HKU SPACE International College (IC) at the time of application and throughout the duration of the exchange activity,
 - b. They are in receipt of means-tested student financial assistance from Student Finance Office (SFO) of the Working Family and Student Financial Assistance Agency (WFSFAA) or whose families are in receipt of the Comprehensive Social Security Assistance (CSSA), and
 - c. They will participate in the study activities as approved by IC.
- 2. General Requirement: students should obtain a minimum average GPA of 2.60, or an average mark of 65, or an average grade B- in their previous academic study programme.
- 3. The study activity must be held in the "Belt and Road" regions as listed in the HK Trade Development Council website (http://beltandroad.hktdc.com/en/country-profiles/country-profiles.aspx) and last for at least 5 days.
- 4. Subsidy for eligible students
 - a. The maximum subsidy in this scheme is subject to the destination of study and the duration of the exchange activity (please refer to the section Subsidy for Students in the notice),
 - b. The amount of subsidy for an eligible student is calculated by applying the approval level of student finance (in terms of percentage of full grant) to the maximum level of subisdy in this scheme based on the latest available application from WFSFAA (e.g. if a student is receiving 50% grant from WFSFAA, then he/she would be eligible to receive 50% of the maximum subsidy under this scheme). However, Interntional College may adjust the actual amount of subsidy to be granted to students downwards from the cap if the travelling expense or programme fee is below the maximum calculated subsidy,
 - c. Students are only eligible for assistance under this scheme up to two times (in 2 different locations) throughout their study in IC at the same level of study in Hong Kong, irrespective of the amount of subsidy received,
 - d. Priority will be given to those who have not received any subsidy under scholarship/sponsorship/subsidy schemes wholly or partly by the Government.
